MAJOR RESEARCH INTERESTS**Severe Maternal Morbidity and Maternal Mortality**

I am currently working on a number of community and policy-oriented projects aimed at addressing the underlying issues that Black women face as they interact with the healthcare system. Since 2018 I have planned, implemented, and hosted the largest Black Maternal Health Symposium in the United States, with 700 people collectively in attendance. I also sit on the Boston Public Health Commission- Community Advocacy Network and the Preconception Health Working Group. I recently worked to develop and edit Bill H.4818 that was recently passed unanimously in the House of Representatives alongside Rep. Liz Miranda. The bill orders the creation of a 25-member special legislative commission made up of experts in the field of maternal health as well as members of the community with lay knowledge, expertise, or experience related to maternal mortality and severe maternal morbidity. The role of the commission is to examine and make recommendations with an aim of reducing or eliminating racial disparities in maternal mortality and severe maternal morbidity. I am also the Principal Investigator of an NIH R01 study (\$3,161,804.00) and an RWJF funded study (\$359,000) addressing maternal health disparities in Black women. I have raised over \$110,000 to support research and community programming for the annual Black Maternal Health conference.

Diversity, Equity, Inclusion, and Anti-Racism

The academy lacks diversity at multiple levels, from student enrollment to the C-suite. I am committed to addressing and ameliorating the gaps in diversity, equity, and inclusion across all levels. Specifically, I am interested in the

development of recruitment and retention programs for students, faculty, and staff at predominately white institutions. To that end, I have led the development of an anti-racism curriculum for medical students which has been implemented in medical schools across the country. Additionally, I serve as a mentor for student affinity groups including the Black Student Alliance and the OB-GYN Minority Student group. I chair the Diversity, Equity, and Anti-Racism Council (DEAR) in my department where I manage 20 faculty, students, and staff across 4 committees. Finally, I chair the research sub-committee of an institution wide committee on anti-racism that includes the revamping of medical education and public health course material.

As a former Kellogg foundation postdoctoral fellow in health disparities, I continue the fight of addressing inequities through my research. I have published lead-authored and collaborative work in journals such as *Racial and Ethnic Disparities*, *Journal of Race and Policy*, *International Journal of Maternal Child Health*, *International Breastfeeding Journal*, the *Journal of Maternal and Child Health*, and most recently the *Lancet*. My most recent book chapter lead comes from the book, *Reproductive Disparities in Black Women* where I discuss the racial gap surrounding infertility.

Infant Mortality

My dissertation examined the effects of neighborhood level disadvantage and the individual level characteristics of race/ethnicity on infant mortality. Social determinants of health theory and ecological theory were used to construct a neighborhood disadvantage index for Washington DC. Secondary analyses were conducted using linked birth/death certificate and census data from the DC State Center for Health Statistics. Multilevel modeling techniques were utilized to determine the relationship between individual and neighborhood level factors on infant mortality. My career trajectory includes the dissemination of research findings that underscore the importance for public health providers and policy makers to focus more intently on the intersection of race and stress in the reduction of infant mortality.

HIV/AIDS

My passion for and commitment to HIV/AIDS is steeped in my 18 years of experience based in underserved communities. The field of HIV/AIDS continues to evolve as HIV progresses from an infectious disease to a chronic disease. Unfortunately, there are still disparities as experienced by certain groups that are disproportionately affected by the disease. Namely, for women of color, HIV/AIDS continues to be the leading cause of death for African American women ages 15-34. To that end, I am working on multiple research projects to stem the spread of the disease.

The four research projects that I am currently working on are:

- **SHARE research study (Stopping HIV/AIDS through relationship engagement)** HIV+ mothers with adolescent daughters in the Greater Boston area will be recruited as dyads for a study on HIV risk, intergenerational trauma and PrEP.
- **Wisdom Matters**- a 6-week health literacy curriculum for HIV+ women
- **Project Thanks (Turning HIV/AIDS into New Knowledge for Sisters)** The purpose of this study is to use a qualitative approach to understand health perceptions, and identify the personal, social, and environmental factors influencing the health seeking behaviors of ethnic minority HIV-positive women with substance abuse disorders.
- **Project DASH (DIVAS Against the Spread of HIV/AIDS)** HIV + mothers with adolescent daughters who self-identified as Black and live in the Greater Newark area were recruited as dyads for the research study.
